Free Dump Day for County Residents

As part of the County’s efforts to reduce illegal dumping, Unincorporated Area residents can drop off up to one ton of trash, free of charge, at Waste Management of Lancaster on October 17, 2009.

With proof of residency, such as a driver’s license, residents can drop off their trash from 8 am to noon.

Free Dump Days are held twice a year, in April and October.

If County residents are unable to attend the Free Dump Day, the following events are available throughout the year:

Free Bulky Item Drop-off: County

residents can drop off one bulky item per year, such as a sofa, table, mattress, etc., free of charge.

Free Waste Tire Drop-off: County residents can drop-off up to four waste tires per year, free of charge.

Waste Management of Lancaster is located at 600 East Avenue F, in Lancaster.

Residents are invited to bring their old tires to be recycled at our free Waste Tire Collection Event on Saturday, October 17, 2009, from 9 am to 3 pm.

The Antelope Valley Environmental Collection Center (AVECC) is open on the 1st and 3rd Saturday of each month, from 9 am to 3 pm. The AVECC is located at the Waste Management of Palmdale, 1200 West City Ranch Road in Palmdale. This Center provides a safe, efficient and convenient method for County residents to drop off their Household Hazardous Waste (HHW) and Electronic Waste (E-waste).



How to STOP Illegal Dumping

Step 1—How to Report

Depending on the situation, there are two ways:

Scenario 1

Catching someone in the act of dumping trash:

Call your local Sheriff's Station:

Palmdale (661) 272-2400
Lancaster (661) 948-8466

Scenario 2

Finding illegal dump sites littering our desert:

Call the Illegal Dumping Hotline:

Step 2—What to Report

Any of the information listed below will make reporting easier:

- License Plate and description of vehicle used to dump
- Date and time that the dumping took place
- Description of dumpers
- Any pictures while in the act of dumping
- ID on dumped vehicles
- Description of what has been dumped
- Location of dump site
- Owner of the property


Step 3—What's Next?


After you report ...


- *Record the 'case number' assigned by the Illegal Dumping Hotline or the Sheriff's 'tag number'.
- *Your report will be assigned to the responsible agency(ies) and an investigation will begin.
- *After gathering enough information and evidence, the case will be given to the District Attorney for prosecution.
- *Once jurisdictional and ownership issues are resolved the waste will be cleaned up.

Get Your Christmas Tree Carried Away

This year when the festivities end, take the work out of getting rid of your Christmas tree by using convenient curbside recycling. Your tree will be recycled into compost, mulch, or ground cover to preserve our natural resources and reduce waste. Here's all you have to do:

-  Place your tree at your curbside on your regular trash collection day from December 26 through January 17. Some dates vary slightly from hauler to hauler.

-  Please remove all items, including water containers, metal and plastic strands, ornaments, tinsel, nails, etc. Trees over six feet must be cut in half. Your tree will be picked up and recycled.

-  If you miss the date for curbside recycling, chop your tree into small pieces and place them in your green waste container.
